The Foundation's strategic plan focus on diversification of revenue to create and position the organization for growth and sustainability to keep pace with the demand for more library locations and services. At the Fort Worth Libraries, people of all ages and socioeconomic background have access to learn and grow. For example, Students of all ages can engage after-school with STEAM programming; adults may earn their High School Equivalency with bi-lingual classes and testing, and exceptional programming aging seniors; people to foster community connection.**
